

United Way of Tucson and Southern Arizona Donor & Data Privacy Policy

I. General

At United Way of Tucson and Southern Arizona your privacy is of the utmost importance. We provide you this Donor and Data Privacy Policy explaining how we treat donor information provided to us either online or offline. This Donor Privacy Policy sets out the basis on which any personal data we collect from you, or that you provide to us as a donor, will be processed by us.

This notice may be changed or updated from time to time by posting such amended or updated notice on this website. If we materially alter this Policy, we will notify you of such changes by posting a notice on our website.

We believe that you should have control over who receives the personal information and data you provide to us as a donor (such as your name, address, zip/postal code, e-mail address, telephone number). Therefore, we do not trade, sell or share your personal information with third parties unless they are carrying out business activities, operations or functions on our behalf. Further, we do not send donor mailings on behalf of other organizations.

II. Data Security

United Way of Tucson and Southern Arizona takes the recommended steps to protect the information collected and provided via the Site from loss, misuse, and unauthorized access, disclosure, alteration, or destruction. We use a variety of security measures to protect your data, including physical, electronic, and procedural safeguards. We incorporate industry standard security controls (like firewalls) and protocols (like SSL/TLS) to create a site that is resistant to standard internet-based threats. We protect the security of credit card transactions by using only large-scale third-party PCI Compliant credit card processors for the storage and encryption of all credit card data, in addition to encryption of websites directly maintained by United Way of Tucson and Southern Arizona.

III. Use and Disclosure of Your Information

By submitting information to us you acknowledge, consent and agree that United Way of Tucson and Southern Arizona may access, read, preserve and disclose the personal information you provide to us as a donor, along with your usage history, submitted messages or data and similar information regarding your use of the website in order to: (a) comply with any applicable law, regulation, legal process, or governmental request; (b) detect, prevent, or otherwise address fraud, security, or technical issues; (c) respond to your requests for customer service; (d) protect the rights, property, or personal safety of United Way of Tucson and Southern Arizona, its visitors, or the public, (e) where we sell any or all our business assets; or (f) as otherwise set forth herein. With your prior consent we may also provide your personal information to the agency you have designated as the recipient of your generosity.
